#### From the Desk of the CEO

A secure and reliable electric grid is the foundation of a modern society. Every sector of American industry, from manufacturing and information technology, to financial services and transportation, depends upon reliable electricity. Electric reliability is front-and-center as October is both Energy Awareness Month and National Cyber Security Awareness Month. These awareness campaigns underscore the importance of active participation from all stakeholders to maintain the reliability and security of our grid.

Energy Awareness Month is an initiative by the U.S. Department of Energy designed to recognize the remarkable role that the energy industry plays in our country, with a focus on security and resilience. As the only state with its own interconnection, Texas has a unique responsibility for the safety of our energy grid, and our stakeholders do an outstanding job. Whether it's working with ERCOT to handle summer load, or responding quickly and effectively to natural disasters like the recent Tropical Storm Imelda, entities in Texas work diligently to ensure power is available for emergency response and recovery.

Cyber security is vitally important to maintaining electric reliability and the national awareness campaign works to remind everyone of cyber security best practices and available tools to help companies practice good cyber hygiene. To ensure that our stakeholders are aware of cyber security trends, Texas RE provides training on cyber security at our workshops throughout the year, including the recent CIP Low Impact Workshop in Houston. Cyber security information is prominent on our website, which includes a CIP evidence request guide and answers to common CIP questions.



Possibly the most indispensable resource for cyber security is the Electricity Information Sharing and Analysis Center (E-ISAC), which works to analyze cyber security threats posed to the electric industry and helps entities deliver a coordinated response. All stakeholders from our region are strongly encouraged to join E-ISAC to receive private-level situational awareness on security threats, including alerts; physical security and cyber security bulletins; remediation; task force reviews; events calendars; and other security-specific resources. Additionally, the E-ISAC's Cybersecurity Risk Information Sharing Program (CRISP) is a platform for energy sector owners and operators to voluntarily share IT system traffic in near-real-time to provide alerts and identify malicious cyber traffic. Participation in CRISP helps to improve the speed and accuracy of data sharing and enhances the ability to detect trends across the sector, identify fast-moving cyber attacks, and deploy effective mitigations before critical systems are affected.

It is appropriate that we conduct our annual membership enrollment and renewal this month when there is a national focus on energy production and cyber security.


#### **GridEx V**

GridEx is a biennial exercise designed to simulate a cyber/ physical attack on electric and critical infrastructure across North America. This is a continent-wide exercise organized by NERC and designed to test the electric sector's crisis response during a large-scale attack on the grid. This event

offers hands-on training with real-time scenarios.

The Fall Standards and Compliance Workshop on October 24, 2019, will include an update regarding the managed release of the Centralized Organization Registration ERO System (CORES) project.

The managed release includes the following stages:

- As of Mid-July 2019, all new registration and change requests must be submitted using the CORES application.
- In August 2019, all focus group and testing entity participants obtained access to CORES and began the validation process.
- Texas RE will continue the rollout process by providing entities access to CORES and requests that entities validate the registration information within CORES and fill out any unpopulated registration sections.

This managed approach gives stakeholders an opportunity to ask questions while navigating through the various sections in the CORES tool and offers a chance to see what can be done to improve the system in the future. # ALIGN

The Align Project Team continues to conduct user acceptance testing, identify critical enhancements, complete data integration and reporting efforts, and develop training materials. The project has been delayed to ensure data security, refine compliance audit and investigation business processes, and address stakeholder concerns. While the training dates have not been determined, the anticipated timeline is in Q1 or Q2 2020. The focus of Release 1 training will still include self-reports, self-logs, mitigation, and enforcement activities. Texas RE will continue to update registered entities through Texas REview, announcements, workshops, and social media on the status of Align and will allow ample time to register for training.

#### **NERC Lessons Learned**

#### Risks Posed by Firewall Firmware Vulnerabilities

A vulnerability in the web interface of a vendor's firewall was exploited, allowing an unauthenticated attacker to cause unexpected reboots of some equipment. This resulted in a denial of service (DoS)1 condition at a low-impact control center and multiple remote low-impact generation sites. These unexpected reboots resulted in brief communications outages (i.e., less than five minutes) between field devices at sites and between the sites and the control center. #### Q: How long do membership terms last?

Membership terms are for one year, beginning November 1 and running through October 31 of the following year.


#### Q: What are the benefits of membership?

Members vote to approve revisions to Texas RE's Bylaws and to elect the four independent directors to the Texas RE Board. Members also select representatives to the Member Representatives Committee (MRC), which provides advice to the Board with respect to annual budgets, business plans and funding mechanisms of Texas RE, matters relevant to the reliability of the BPS, and any other matters pertinent to the purpose and operations of Texas RE. Additionally, members will be able to attend the Texas RE Annual Membership meeting on December 11, 2019. Former PUCT and FERC Chairman Pat Wood is the guest speaker.

#### Q: What are the requirements to be a member?

New members must submit a completed application form to Texas RE Information. Following review of the application, an entity receives a Membership Agreement for review and signature. Each qualifying entity may be registered in only one sector.

## Questions and Answers about Texas RE Membership, cont.

Q: Is membership renewal automatic?

Membership renewal is **not automatic**. The primary and alternate contacts of current members received a renewal form with instructions on October 2. Please note that the member contacts are often different from the primary and alternate compliance contacts. If you have any questions about the current status of your company's membership and who the membership contacts are, review the <u>current membership list</u> on Texas RE's website.

Q: Is it free to become a Texas RE member?

Yes.


Q: Does my company have to be a NERC registered entity to become a member?

If your company qualifies for the Load-Serving and Marketing sector, it does not have to be a NERC registered entity to become a Texas RE member.

## Talk with Texas REcap—Extranet Updates

Effective October 1, 2019, Texas RE's Extranet site has been enhanced with a document submittal structure that will eliminate the need for registered entities to populate and submit the Evidence Index spreadsheet for Audit, Spot Check, and Self-Certification activities. The enhancements will streamline the process, eliminate the manual entry of populating the Evidence Index with document titles and NERC Standards and Requirements, avoid confusion of document naming



conventions, and expedite the transfer of documents for engagement activities. The Extranet structure will not change for Registration, Certification, Risk, and Enforcement activities.

For each engagement activity, Evidence and RSAW subfolders will be present. The Evidence subfolder will contain NERC Standard and Requirement subfolders based on the scope of the engagement. The RSAW subfolder will house all RSAW documents submitted by the registered entity. ## **ERCOT Operator Training**

ERCOT recently held its 35th Annual Operator Training Seminar at its new training facility in Taylor, Texas. The three-day sessions for TDSPs, TOPs, QSEs, and Generation Operators included speakers from key organizations throughout the Texas Interconnection and covered topics such as human performance, emerging technologies, voltage control, congestion management, inertia, and more. Mark Henry, Texas RE's Director of Reliability Services, delivered a presentation on lessons learned from events that impacted the bulk power system in Texas and in other regions.
